Hiring Office:	Lao Country Office
Purpose of consultancy:	To provide technical support to develop out-of-school CSE curriculum framework including updating out-of-school CSE training manual, instructor's guidelines and CSE IEC materials.
Scope of work: (Description of services, activities, or outputs)	UNFPA supports the Ministry of Education and Sports (MoES) to roll out the out-of-school CSE Roadmap <i>in selected marginalised provinces in Lao PDR. This initiative aligns with the national commitment at the NCPD (2023) to fully integrate CSE into all levels of formal/ informal education.</i> UNFPA supported the development of the Roadmap for Comprehensive Sexuality Education for Out-of-School Adolescents and Youth in Lao PDR (2025-2030), which is guided by the principles of youth leadership, human rights, gender transformation, and inclusion. It considers the diverse needs of specific groups of adolescents and youth, including girls, ethnic minority groups, adolescents and youth with disabilities, and LGBTQIA+ youth, ensuring that no one is left behind. The roadmap provides a strategic framework to increase access to comprehensive sexuality education for adolescents and youth aged 10 to 25 who are not enrolled in any formal education system. However, effective out-of-school CSE requires resources designed with meaningful input from adolescents and youth, aligned with global standards, addressing critical topics such as gender equality, health, and rights, and being adaptable to diverse contexts. UNFPA is looking for an international consultant to support the Ministry of Education and Sports in developing the out-of-school CSE curriculum including updating out-of-school CSE training manual, instructor's guidelines and CSE IEC materials, targeting out-of-school young people in diverse contexts with support of a national consultant.
Duration and working schedule:	The consultancy is envisioned for a tenure of 30 days spreading over from 20 th May to 20 th July 2025
Place where services are to be delivered:	This is a home-based assignment, with regular virtual meetings taking place with the UNFPA Country Office. The international consultant is required to remain available online and via phone during the tenure of the consultancy.
Delivery dates and how work will be delivered (e.g. electronic, hard copy etc.):	The key tasks of the consultant include:

- 1.) Review of MoES's current strategy, sector plans, policy, curriculum materials, and other frameworks for including and **prioritizing CSE for out-of-school young people.**
- 2.) Review and update existing out-of-school **CSE training manual** and **IEC resources available on CSE.**
- 3.) Supervise national consultant, who will primarily be responsible for conducting meetings/workshops with relevant stakeholders, reporting and supporting the international consultant in the local context.
- 4.) **Support consultations/ meetings** (moderated by the national consultant) with relevant stakeholders including the Ministry of Education and Sports, Provincial Education Departments, mass organisations, adolescents and youth groups, INGOs, UN Agencies and other development partners.
- 5.) Develop out-of-school **CSE curriculum framework** (identify CSE learning outcome, learning objectives, key contents/messages, etc for specific groups of adolescents and young people catering to various age groups and update the existing out-of-school CSE training manual/instructor's guidelines and IEC materials based on overall designed curriculum framework-aligned with International Technical and Programmatic Guidance on Out-of-School CSE, ensuring innovative, creative, safe and engaging approaches. The developed CSE resources can be used for both offline and online platforms.
- 6.) **Conduct virtually the technical workshop** with MoES and UNFPA to validate the draft overall designed curriculum framework including updated out-of-school CSE training manual/instructor's guidelines and IEC materials for inputs.
- 7.) **Finalize** the out-of-school CSE curriculum framework, out-of-school CSE training manual/Instructor's guidelines and IEC materials.
